The format for commercial and Technical bid are attached as Appendix to this letter. The envelopes should be clearly marked **TECHNICAL/COMMERCIAL BIDS**. The Technical Bid shall be opened first and only if found valid & suitable then the Commercial Bid would be opened. During the intervening period the Board of Officers/Teachers is at liberty to visit the shop/establishment of the bidder and select the firms/dealers for opening of Commercial Bids. The decision of the Board shall be final & binding on all and no representations in this regard will be entertained.
3. **Specifications**. Specifications mentioned in **Financial Bid**. Items as specified only are to be used. Items not found genuine/satisfactory shall be rejected and the supplier will remove the same from the school at his own cost.
4. **Cost of Tender Document**. DD of Rs 100/- payable to Principal, Army Public School, SP Marg payable at Lucknow to be attached with technical bid. Technical Bids not accompanied with the Demand Draft will be rejected.
5. **Bid security/EMD (refundable)**. All Technical Bids must be accompanied with a Demand Draft of Rs 10,000/- (Rupees ten thousand only) payable to the 'Principal, APS, SP Marg, Lucknow' which is refundable EMD to non-acceptance of the tender. All Technical Bids not accompanied with the Demand Draft will be rejected.
6. **Time for Completion of Works**. Time for completion of the project will be specified in the work order. In no case period of completion of work would be more than **04 weeks** from the date of receipt of the order.
7. **Performance Security**. Performance security between 5-10% of project cost will be taken from the L1 vendor within 10 days of the receipt of supply order. The performance security should remain valid for a period of sixty days beyond the date of completion of the project.

8. **Payment Terms.** Full payment will be made through NEFT in the name of Firm after deducting **LD charges (0.5% per week upto max 10% of project cost), if any**, on completion of work & checking by the board and endorsing certificate that the quantity & quality of material used is of standard quality, as per specification/description and work is satisfactory.

9. **Acceptance of Tenders.** The Tenders/quotations are to be submitted in two envelopes and marked as under: -

10. **Opening of Tenders.** The Tender to be put in the tender box placed at Army Public School, SP Marg, Lucknow. Last date of deposit the tender is 28 May 2026 at 1200h and the **Tech Bid** will be opened on the **same day at 1230h. (Tentatively)**

11. The school reserves the right to alter the quantities mentioned or to reject any tender with valid reasons thereof and no representation in this regard would be entertained

12. Ensure to attach all relevant document with tender to avoid rejection.

13. On site visit of location for installation should be verified physically and checked before submitting the quotation during the Pre-Bid Meeting.

14. **MSME and Startups will be given due relaxation as per Govt Norms.**

15. **Dispute Resolution.** In the event of any dispute or difference between the parties hereto, such dispute or difference shall be resolved amicably by mutual consultation. Final deciding authority will be Chairman, APS, SP Marg, Lucknow.
